### Description

The action is based on combining the barrier properties of non-polar oils with the skin-toughening tanning agent Hamamelis.

Light and easy to apply, Stokoderm® Aqua PURE is swiftly absorbed into the skin and helps to keep skin feeling smooth and healthy while working with harsh workplace substances. Extensive application testing confirmed high cosmetic acceptance by users.



### Area of Application

Stokoderm® Aqua PURE supports the natural skin barrier when frequently in contact with water or water-based workplace substances (water-based cooling lubricants, water-based solutions of dyestuffs, acids, alkaline solutions, salts, cleaning agents and disinfectants, cement, lime and fertilizers), as well as when wearing occlusive protective clothing.

### Skin Compatibility Tests

Stokoderm® Aqua PURE has proven to have very good skin compatibility properties in human-experimental tests and in practical use.

Medically certified skin compatibility expert reports prepared by Prof. Dr. med. S. W. Wassilew, MD for Dermatology, Allergology, Environmental Medicine, are available upon request.

### Efficacy Tests

The product's action when used as a pre-work cream was tested using the repetitive, occlusive irritation test. Stokoderm® Aqua PURE supported the skin's natural barrier function against the standard irritant sodium lauryl sulfate and supported restoring the skin's natural barrier, when irritated by sodium lauryl sulfate.

### Glove compatibility test

Tests to determine the compatibility of Stokoderm® Aqua PURE with the most common forms of materials used in gloves (latex, nitrile and neoprene) were carried out on the basis of the ASTM standard D-412 (measuring the tensile strength; Ansell Science & Technology, Massillon, Ohio, USA). Stokoderm® Aqua PURE has not been found to have any statistically significant effect on the tensile strength of the materials used in gloves after they have been worn for the period usual in practice of less than 2 hours.

### ECARF Seal of Quality

The European Centre for Allergy Research Foundation (ECARF) awards the ECARF-quality seal to allergy-friendly products. Cosmetics can receive this seal when following criteria are met:

1. Quantitative risk assessment of the product ingredients with respect to their potential for sensitization, taking into account their specified conditions of use and amount
2. Medically supervised clinical trials by volunteers with atopic dermatitis
