Efficacy Tests

The protective action of Stokoderm® Grip PURE was tested on the analogue product with preservatives using the modified Repetitive Occlusive Irritation Test (ROIT), a modern skin physiology in vivo process. The protective action was tested. The model irritants are occlusively applied to the skin twice a day for 30 minutes over a period of four days. The resulting skin irritation is defined and compared with the help of the visual score (VS); the resulting barrier damage with the help of the transepidermal water loss (TEWL).
