WHERE TO USE

HOW TO USE

- Do not wet soiled hands
- Rub in small amount of product thoroughly
- Add a little water and continue washing
- Rinse with plenty of water and dry thoroughly
- Repeat process after drying hands if necessary

Please note: A slightly sulphurous odor and a slight temperature increase while hand washing may result from the color neutralizing agent breaking down dyes.
