Skin Compatibility Tests

The 48hr Single Patch Test results have been validated by a dermatologist to show the product to be 'non-irritant'.

Glove compatibility test

Tensile properties were determined using tests based on EN 455 – 2:2009. The product has been shown not to have an effect on latex and nitrile gloves.

Efficacy Tests

In Vivo test shows that the product reduces irritation when the skin is exposed to an irritant material.

In Vitro paper chromatography method shows the product has excellent barrier properties against aqueous based materials.

Non-taint test

Product has been tested according to Sensory Analysis – Methodology - Triangle Test BS EN ISO 4120:2007. Proven to not have the potential to taint food when used as a pre-work cream.
