### **SHELF LIFE**

This product has a shelf life of at least 30 months from the date of manufacture when stored unopened at room temperature.

# PRODUCT SAFETY ASSURANCE

Skin Compatibility Test: The skin compatibility of Stokolan® Hand & Body was tested using state of the art dermatological tests using voluntary tests panels. In these tests, as well as in practical use, Stokolan® Hand & Body has proven to have very good skin compatibility.

Toxicological Approval: Formulation assessed by a toxicologist and declared safe to use.

# **MOISTURIZATION TESTS**

Effect on Skin Hydration: In the course of a 2-week application test the rehydration effect and care quality of Stokolan<sup>®</sup> Hand & Body was tested on 15 persons. After one week application of Stokolan® Hand & Body, the skin hydration level had risen 12% and by about 19% after two weeks. Stokolan® Hand & Body has very good cosmetic properties, improves skin smoothness and enhances skin moisture.
